BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT CAMINO DE LA PLAZA/EAST BEYER BOULEVARD AND SAN YSIDRO BOULEVARD, AND MODIFICATION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT EUCLID AVENUE AND LOGAN AVENUE/OLVERA AVENUE, San Diego, California, filed in the office of ~~the City~~ Clerk of the City of San Diego, California, on JUN 11 1984 and bearing official Document No. W.O. 122407 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT CAMINO DE LA PLAZA/EAST BEYER BOULEVARD AND SAN YSIDRO BOULEVARD, AND MODIFICARITON OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT EUCLID AVENUE AND LOGAN AVENUE/OLVERA AVENUE.

BE IT FURTHER RESOLVED, that the total expenditure of \$212,850.00, not to exceed \$112,850.00 from Gas Tax Fund 30219, and not to exceed \$100,000.00 from Capital Outlay Fund 30245, CIP No. 62-229 CAMINO DE LA PLAZA, EAST BEYER BOULEVARD AND SAN YSIDRO BOULEVARD is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
