BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of that street easement deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of April 10, 1984, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 260902, granting to said City an easement for public street purposes in a portion of the Northeast Quarter of Section 13, Township 14 South, Range 4 West, S.B.M.; in a portion of the Northwest Quarter of Section 18, Township 14 South Range 3 West, S.B.M., and in Black Mountain Road Vacated, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named HIGH BLUFF DRIVE, WYNDHAVEN DRIVE and QUARTER MILE DRIVE.

BE IT RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
