WHEREAS, it is desired that said positions be filled by individuals possessing the greatest ability and expertise; and


WHEREAS, it is further desired to conduct a personnel search to identify and secure possible candidates for these higher ranking positions; and

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to set aside and encumber the sum of \$20,000 from the General Fund 100, Department 601, Organization 137, "Special Consulting Services," for the purpose of hiring an Executive Search Firm to recruit and recommend candidates for Deputy Director positions.
