

RESOLUTION NUMBER R- 260937

Adopted on JUN 12 1984

WHEREAS, the Planning Commission of The City of San Diego held concurrent public hearings on May 17, 1984, to consider proposed amendments to the MIRA MESA COMMUNITY PLAN and amendment of the General Plan Map in order to retain consistency between said plans; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of amendments to the MIRA MESA COMMUNITY PLAN and amendment of the General Plan Map; and

WHEREAS, City Council Policy 600-7, requires that the public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, on May 17, 1984, the Planning Commission approved and recommended for adoption by the City Council an amended GENERAL PLAN; and

WHEREAS, California Government Code, Section 65361 provides that mandatory elements of the GENERAL PLAN may not be amended more than four times per year; and

WHEREAS, it is the intention of the City Council to consider amendments to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semi-annual basis; and

WHEREAS, it is the intention of the City Council to conduct

a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the proposed amendments to the MIRA MESA COMMUNITY PLAN; and


WHEREAS, the Council of The City of San Diego, by majority vote, approved the proposed amendments of the MIRA MESA COMMUNITY COMMUNITY PLAN; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That this Council hereby approves the amendments to that plan entitled MIRA MESA COMMUNITY PLAN, by the incorporation of the Pacific Corporate Center amendment to the circulation element of the MIRA MESA COMMUNITY PLAN, amending the designation of Camino Santa Fe and Carroll Canyon Road and amendments to the language of such plan describing the design of Mira Mesa Boulevard, a copy of which is on file in the office of the City Clerk as Document No. 84-275.

2. That the amendments to the MIRA MESA COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans, an omnibus hearing on this and other amendments having been scheduled on or about July 1984.
