2. The second low bid of BURNS & SONS TRUCKING for REMOVAL AND DISPOSAL OF APPROXIMATELY 40,000 CUBIC YARDS OF DIGESTED SLUDGE ON FIESTA ISLAND at a cost of \$8.45 per cubic yard for a total cost of \$338,00.00; terms net 30 days.

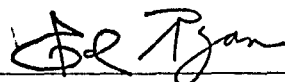

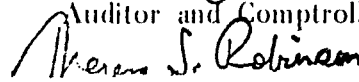
