BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$8,400.00 from Gas Tax Fund 30219, CIP No. 37-310 STREET LIGHT CONVERSION to Capital Outlay Fund 30245, CIP No. 37-130 ANNUAL ALLOCATION - STREET LIGHT CIRCUIT REPLACEMENT AND CONVERSION.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$111,475.00 from Capital Outlay Fund 30245, CIP No. 37-130 ANNUAL ALLOCATION - STREET LIGHT CIRCUIT REPLACEMENT AND CONVERSION is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
