BE IT FURTHER RESOLVED, that the Purchasing agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF COMMUNITY CONCOURSE PARKADE SECURITY LIGHTING.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$43,000.00 from CIP No. 37-002 ANNUAL ALLOCATION - ENERGY CONSERVATION IMPROVEMENTS to CIP No. 37-409 COMMUNITY CONCOURSE PARKADE - LIGHTING.

BE IT FURTHER RESOLVED, that the total expenditure of \$103,000.00 from Capital Outlay Fund 30244, CIP No. 37-409 COMMUNITY CONCOURSE PARKADE - LIGHTING is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
