BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$20,000.00 from the Park Service District Fund 11512 to CIP No. 29-540 KATE SESSIONS PARK - PARKING LOT STORM DRAIN.
