


RESOLUTION NUMBER R- 260980

Adopted on JUN 18 1984

BE IT RESOLVED, that the City Council of The City of San Diego, hereby approves the Transportation and Land Use Committee's recommendations to the City Manager with respect to traffic problems around Horseman's Park, as follows:

1. Request the City Manager to reduce the posted speed limit on Black Mountain Road in the vicinity of Horseman's Park to 35 mph.
2. Request the placement of warning signs alerting drivers to stop for horses and riders crossing the road.
3. Approve the concept of signalization of some nature that will act to significantly decrease the current hazards associated with horses crossing Black Mountain Road. This latter recommendation is contingent upon the availability of funding for this activity by the City Council during the current budget process.
