

RESOLUTION No. R-260984 (R-84-2189)

Adopted on JUN 25 1984

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. ELECTRIC SUPPLIES DISTRIBUTING, 2. COUNTY WHOLESALE ELECTRIC, 3. GENERAL ELECTRIC SUPPLY CO. and 4. SAN DIEGO WHOLESALE ELECTRIC CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LAMPS as may be required for a one (1) year period beginning July 1, 1984 through June 30, 1985, per prices on file in the Purchasing Department, with an option to renew contract for an additional one (1) year period as follows:

1. ELECTRIC SUPPLIES DISTRIBUTING for Sections I and II; terms 3% 21 days, plus sales tax; and Section VII, Items 6 and 10; terms net, plus sales tax.
2. COUNTY WHOLESALE ELECTRIC for Sections III, IV and VII, Items 1, 2, 3, 5 and 11; terms net, plus sales tax.
3. GENERAL ELECTRIC SUPPLY CO. for Sections V, VI, and VII, Items 7, 8, and 9; terms 2% 20 days, plus sales tax.
4. SAN DIEGO WHOLESALE ELECTRIC CO. for Section VII, Item 4; terms 2% 25th prox., net 30 days, plus sales tax.
