
RESOLUTION NUMBER R- 261020

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of that street easement deed of JAMES NAISMITH and IRENE NAISMITH, executed in favor of The City of San Diego, bearing date of May 15, 1984, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 261020, granting to said City an easement for public street purposes in Lot 21, Block 14 of Grantville and Outlots, Map 776, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MISSION GORGE ROAD.
