

RESOLUTION NUMBER R- 261021

Adopted on JUN 25 1984

WHEREAS, there were relinquished to the City of San Diego certain abutter's rights of access in and to Carmel Mountain Road from Lot 62 of Penasquitos Scene, Map 8319; and

WHEREAS, DANIEL CONDRICK has requested that the City revest those access rights to allow for better utilization of the property; and

WHEREAS, the access rights were acquired at no cost, and DANIEL CONDRICK has paid all City costs in connection with processing the matter of revesting the access rights; and

WHEREAS, the processing costs of revestment will be the consideration for the sale of the City's rights; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 261021-2, quitclaiming to DANIEL CONDRICK all the City's right, title and interest in the abutter's rights of access, as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
