

RR- 261022 - 1, be and the same is hereby changed to RIVER RUN DRIVE.

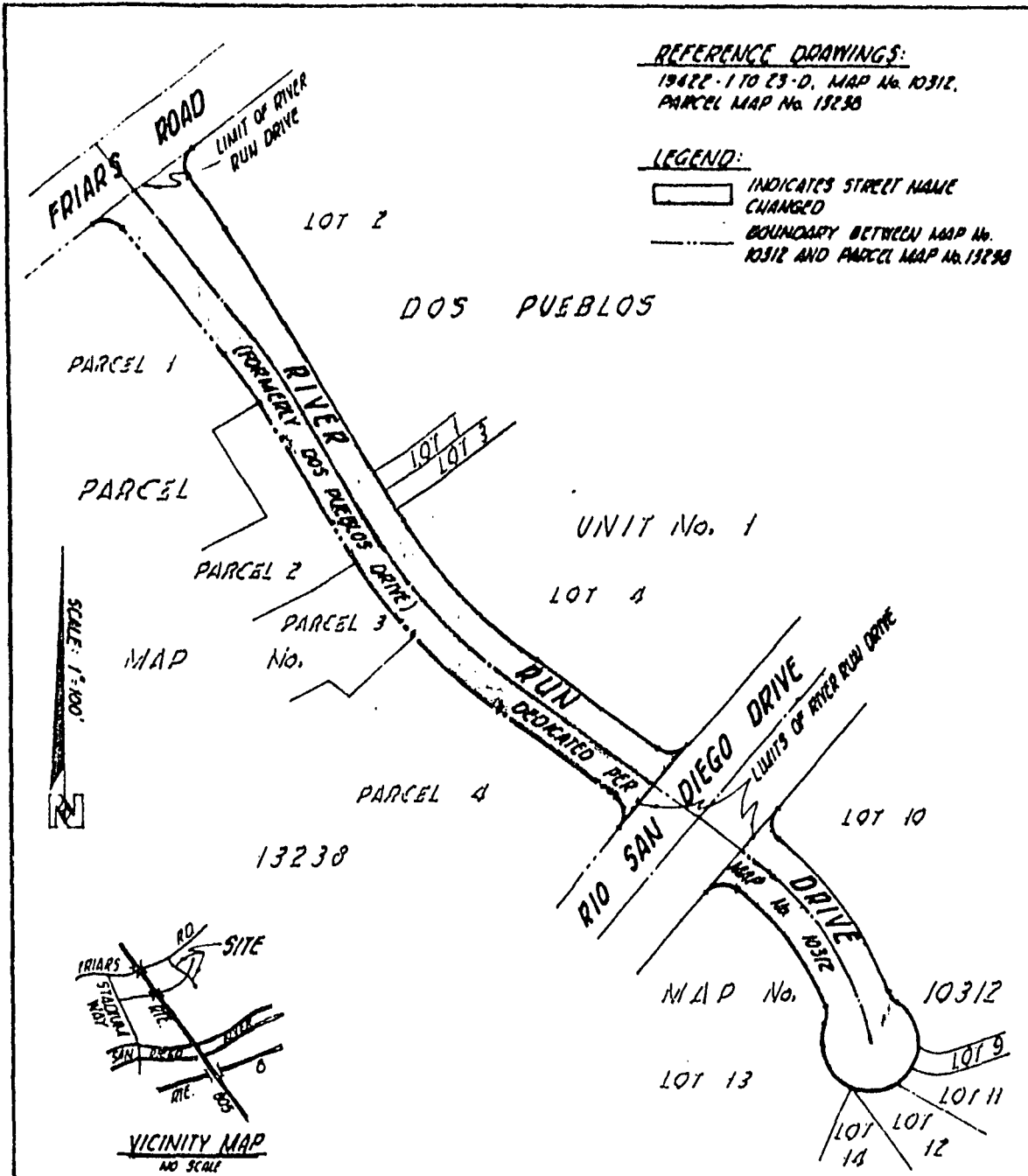

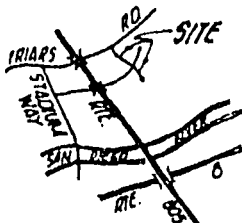
