In the event that a Memorandum of Understanding is not in effect or in the the event an employee organization participates in, supports, cooperates or encourages, directly or indirectly, any strike, sickout or other total or partial stoppage or slowdown of work. the City may discontinue the payroll deduction of membership dues and insurance premiums for the Recognized Employee Organizations or in the alternative make such payroll deductions subject to such administrative procedures as the City finds appropriate. Notwithstanding the foregoing, employees using the payroll deductions system to pay membership dues and/or insurance premiums to an employee organization, not the Exclusively Recognized Employee Organization, for the bargaining unit to which they are assigned, as of January-8,-1982 July 1, 1984, may continue to have such deductions made and may amend such deductions from time to time. Payroll deductions for employees not having deductions made to an employee organization as of January-87-1982 July 1, 1984, will be processed only for the bargaining unit to which the employee's class is assigned.
