WHEREAS, San Diego Municipal Code Section 54.0204 authorizes the San Diego Fire Department to inspect private properties to cause owners to clean up and remove overgrown weeds, grass, brush and/or rubbish and combustible waste; and

WHEREAS, Fire Department personnel have completed the inspection phase and have given notice to owners of the existence of hazardous conditions on their properties and of the Fire Department's intention to abate these hazardous conditions, all as required by San Diego Municipal Code Section 54.0204; and

WHEREAS, sufficient time, a minimum of 30 days, has been granted and elapsed for each owner to successfully perform cleanup operations on said properties; and

WHEREAS, property owners who contested the proposed abatement of their properties were given an opportunity to be heard before an independent hearing officer on June 4, 1984, in accordance with San Diego Municipal Code Section 54.0205; and

WHEREAS, it is estimated that the properties described in Document No. R-261029, on file in the Office of the City Clerk, still constitute a hazard and will require abatement by the City.

BE IT RESOLVED, by the Council of the City of San Diego, that the City Council hereby declares that all properties described in Document No. R-261029, on file in the

City Clerk's Office and incorporated herein by reference, contain weeds and/or rubbish which constitute an extreme fire and health hazard and a public nuisance.

BE IT FURTHER RESOLVED, that the City Manager, or his designated contractor, is hereby authorized and ordered to proceed to abate those nuisances which are declared to exist on the properties more particularly described in Document No.
