BE IT FURTHER RESOLVED, that the expenditure in the amount not to exceed \$4,000.00 for annual auditing by Gunnarson and Bates and \$11,130.00 for annual program monitoring by George A. Peterson & Co., multi-year contracts which have been previously approved subject to availability of funding.

BE IT FURTHER RESOLVED, that the total expenditure in the amount not to exceed \$423,000.00, for the tenth year of the project from Fund 18520, Department 5817, Organization No. 1704, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
