WHEREAS, Mr. Witzel's activities in Sacramento have been authorized by a nonexclusive contract since 1979; and

WHEREAS, in addition to a personal services agreement, the City leases office space from the League of California Cities under a three-year lease, in 1982, the City sublet the office space to Mr. Witzel, concurrent with his employment by the City; and

WHEREAS, this change was made so that Mr. Witzel would pay a portion of the lease cost because he contracts with clients whose interests do not conflict with the City's; and

WHEREAS, before 1982, the City provided office space at no cost to the contractor; and

WHEREAS, the Director of Intergovernmental Relations, in his Report No. 84-31 dated June 5, 1984, recommended to the Rules Committee that the Personal Services and Office Sublease Agreements with John M. Witzel, Inc. be renewed for a period of one year; and

WHEREAS, the Rules Committee reviewed said recommendation on June 11, 1984 and approved the same; and

WHEREAS, the Rules Committee now forwards the matter to the full Council recommending approval of the recommendation and renewal of the agreements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, the Personal Services and Office Sublease Agreements with John M. Witzel, Inc. for the purpose of providing Sacramento legislative representation, for the period July 1, 1984 through June 30, 1985, pursuant to the terms and conditions of those agreements on file in the office of the City Clerk as Documents No. RR-261046-/ and RR-261046-2.
