That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Loren E. Southwick	Engineering & Development	\$2,500	Mr. Southwick was an Assistant Civil Engineer at the time he submitted his suggestion. One year ago he suggested eliminating the sand and seal requirement on trench resurfacing. One year's experience has shown a savings of \$24,000.00. This is the remainder of his award.
Douglas S. Johnson	General Services	\$1,995	Mr. Johnson was a Machinist in the Equipment Division at the time of his suggestion. He suggested the fabrication of oversize clamp shoes and clamp shoe sockets to reduce wear on the Leach packers. His suggestion is expected to save \$13,302.86 in time and materials.
Paul G. Zielins	General Services	\$1,545	Mr. Zielins was a Mechanic in the Equipment Division at the time of his suggestion. He suggested modification of the Leach Trash Compactors to eliminate slipping problems and reduce the breakage rate. This is expected to save \$11,273.20 in time and materials during the first year.
