Jose A. Barron, Jr.	Park and Recreation	\$1,310	Mr. Barron was an Area Manager I at the time he submitted his suggestion. He suggested turning off security lighting in and around Park and Recreation facilities to deter vandalism and conserve energy. This is expected to save \$4,357.00 in energy costs during the first year.
Vincent DeLeva	General Services	\$ 840	Mr. DeLeva was an Electrical Supervisor in the Communication and Electrical Division at the time he submitted his suggestion. He suggested contacting CalTrans regarding shared energy and maintenance costs for street lights which benefit State and City. This is expected to save \$2,806.99 during the first year.
James A. Froslic	General Services	\$ 830	Mr. Froslic was a Service Writer at the time of his suggestion. He suggested the purchase of a different taper lock for the 5700 trash trucks. This is expected to save \$2,774.24 in time and material.
