Jerry Vistercil	General Services	\$ 295	Mr. Vistercil is an Equipment Repair Supervisor in the Equipment Division. He suggested to render inoperative the fan clutches on ten rubbish packing vehicles. This is expected to save \$1,966.98 in the first year in time and material.
James A. Froslic	General Services	\$ 245	Mr. Froslic was a Service Writer in the Equipment Division at the time he submitted his suggestion. He suggested installing a spacer block between the spring and axle of the 5700 Trash Packers. This is expected to save \$814.96 in time and material.
Hubert E. Tipton	General Services	\$ 170	Mr. Tipton was a Utilityman I at the time he submitted his suggestion. His suggestion was to recycle lamps at signalized intersections. This is expected to save \$567.00 in the first year.
