RESOLUTION NUMBER R- 261060

Adopted on JUN 26 1984

WHEREAS, certain slope and drainage easements were acquired and certain abutter's rights were relinquished to the City for the construction of La Jolla Village Drive (formerly known as Miramar Road); and

WHEREAS, said road has been constructed and the slope and drainage easements are no longer needed; and

WHEREAS, E. F. HUTTON LIFE INSURANCE COMPANY, a California corporation, has requested that the City revest a portion of the access rights in and to La Jolla Village Drive; and

WHEREAS, the City has no present or prospective public use for the slope and drainage easements or the access rights and the City Manager has recommended that the City abandon and revest its interests therein; and

WHEREAS, the City has since recovered their acquisition costs and E. F. HUTTON LIFE INSURANCE COMPANY, a California corporation, has paid all City costs in connection with processing the matter of quitclaiming the easements; and

WHEREAS, the processing costs of the abandonment will be the consideration for the sale of the City's rights; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San

Diego, a quitclaim deed, on file in the office of the City Clerk as Document No. RR- 261060-1, quitclaiming to E. F. HUTTON LIFE INSURANCE COMPANY, a California corporation, all the City's right, title and interest in the slope and drainage easements, and revesting those access rights, as more particularly described in said quitclaim deed.

2. That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
