VARIOUS LOCATIONS CITY WIDE 1984.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$60,000.00 from CIP No. 62-002 ANNUAL ALLOCATION - MINOR SIGNAL IMPROVEMENTS, \$64,000.00 from CIP No. 62-242 FIFTH AVENUE AND PENNSYLVANIA AVENUE, and \$20,000.00 from CIP No. 62-233 GARNET AVENUE AND MISSION BOULEVARD TO CIP No. 62-001 ANNUAL ALLOCATION - HIGH ACCIDENT LOCATIONS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$200,500.00; \$176,500.00 from Capital Outlay Fund 30245, CIP No. 62-001 ANNUAL ALLOCATION - HIGH ACCIDENT LOCATIONS and \$24,000.00 from Gas Tax Fund 30219 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
