BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Director of the City be, and he is hereby authorized to request proposals for and to execute an agreement with a consultant to analyze the Growth Management Strategy adopted in 1979, as described in the sections of the Progress Guide and General Plan entitled "Introduction" and "Guidelines for Future Development."

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$50,000.00 from Dept. 065, Org. 102, Account 4151 is hereby authorized solely and exclusively for providing funds for said project and related costs.
