
A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE ISSUANCE OF TAX ALLOCATION BONDS BY THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO FOR THE COLUMBIA AND THE MARINA PROJECTS.

WHEREAS, the Council of The City of San Diego has previously given its general approval to financing plans for the Columbia Project and for the Marina Project of the Redevelopment Agency of The City of San Diego; and

WHEREAS, said financing plans included tax allocation bond issues to finance public facilities within each of the above-named project areas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council approves the issuance by the Redevelopment Agency of The City of San Diego of a tax allocation bond issue for the Columbia Project in the aggregate principal amount of not to exceed \$15 million and a tax allocation bond issue for the Marina Project in the aggregate principal amount of not to exceed \$25 million for purposes of financing public facilities in each of the aforementioned project areas.
