2. That the City Auditor and Comptroller is hereby authorized to transfer \$13,033.00 from CIP NO. 58-004 ANNUAL ALLOCATION - MISCELLANEOUS IMPROVEMENTS ON CITY STREETS to CIP No. 12-048 "L" STREET DRAIN.
3. That the expenditure of \$13,033.00 from CIP NO. 12-048 "L" STREET DRAIN to supplement \$137,500.00 in funds previously authorized by Resolution No. 260587, adopted May 7, 1984, is hereby authorized solely and exclusively for said project and related costs.
