CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE TREE MAINTENANCE AND LITTER CONTROL FOR THE PARK AND RECREATION DEPARTMENT, COASTAL DIVISION, as may be required for a period of twelve (12) months beginning July 1, 1984 through June 30, 1985, at an annual cost of \$24,116.40, with an option to renew contract for two (2) additional twelve (12) month periods with a price escalation not to exceed 10% of bid prices.
