WHEREAS, in approving the final map of LA PAZ subdivision, the City shall receive easement interests which will allow the quitclaim of an existing drainage easement within the area of the subdivision; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 261115 -1, quitclaiming to DONALD L. BREN, all the City's right, title and interest in the drainage easement, as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause the deed and a certified copy of this resolution; attested by him under seal, to be recorded in the office of the County Recorder.
