BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the petition of property owners in the Lopez Canyon Stormwater Retention Basin Maintenance District in said area be and is hereby accepted, said petition is on file in the office of the City Clerk as Document No. RR-261133.

2. That the external boundaries of the proposed district shall be the boundaries described in the map "Proposed Boundaries of the Lopez Canyon Stormwater Retention Basin Maintenance District" on file in the office of the City Clerk as Document No. 768974.

3. That the district will be for maintenance purposes only and the district proposes no construction of facilities at this time.

4. That the City Manager is hereby authorized to initiate proceedings for the formation of said maintenance district pursuant to the San Diego Maintenance District Procedural Ordinance of 1975, said district shall be known and designated as the Lopez Canyon Stormwater Retention Basin Maintenance District.
