BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fourth Amendment to Agreement between The City of San Diego and the American Red Cross, San Diego Chapter, on file in the office of the City Clerk as Document No. RR-255869-3, for the purpose of

providing lift-equipped transportation to eligible passengers of the City's Dial-A-Ride program in the San Diego Central area, all pursuant to the terms and conditions of the Fourth Amendment to the Agreement on file in the office of the City Clerk as Document No. RR- 261147.
