

RESOLUTION NUMBER R- 261171

Adopted on JUL 16 1984

BE IT RESOLVED, by the Council of The City of San Diego, that the granting of fee title of portions of Rancho San Bernardo, located in the city of Escondido to the CITY OF ESCONDIDO, for the purpose of widening Via Rancho Parkway, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the granting of easements over portions of Rancho San Bernardo to the CITY OF ESCONDIDO for slope and drainage purposes, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, two (2) grant deeds for the purposes of widening of Via Rancho Parkway, and three (3) easement deeds for slope and drainage purposes, to the CITY OF ESCONDIDO, under the terms and conditions set forth in those grant deeds and easement deeds on file in the office of the City Clerk as Documents Nos. RR- 261171-1 , RR- 261171-2 , RR- 261171-3 , RR- 261171-4 and RR- 261171-5.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Street Improvement and Right-of-Way Agreement with the CITY OF ESCONDIDO, for the purpose of improvement of Via Rancho Parkway, under the terms and

conditions set forth in that Street Improvement and Right-of-Way Agreement on file in the office of the City Clerk as Document No. RR- 261171-6 .

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Right of Entry Permit to the CITY OF ESCONDIDO, for the construction of a walkway and appurtenances thereto, under the terms and conditions set forth in that Right of Entry Permit on file in the office of the City Clerk as Document No. RR- 261171-7 .

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept a Quitclaim Deed from the CITY OF ESCONDIDO, conveying excess lands to The City of San Diego, a copy of which Quitclaim Deed is on file in the office of the City Clerk as Document No. RR- 261171-8 .
