RESOLUTION NUMBER R- 261184

Adopted on JUL 16 1984

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 85.04 of the San Diego Municipal Code, the use of the following described streets be and they are hereby prohibited at all times to commercial vehicles of the rated capacity of one ton or more:

SEMILLON BOULEVARD between Avenida Magnifica and Pomerado Road; AVENIDA MAGNIFICA between Semillon Boulevard and Mesa Madera Drive; MESA MADERA DRIVE between Avenida Magnifica and Red Cedar Drive; RED CEDAR DRIVE between Mesa Madera Drive and Ironwood Road; IRONWOOD ROAD between Scripps Ranch Boulevard and Red Cedar Drive.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and they are hereby authorized to be made on said streets.

BE IT FURTHER RESOLVED, that the regulations hereinabove imposed shall become effective upon the installation of such signs.
