WHEREAS, the Council of The City of San Diego finds that it is necessary to close certain portions of Pomerado Road for the safety and protection of persons who will use that road during the time that improvements to Pomerado Road will be made pursuant to the contract on file in the office of the City Clerk as Document No. RR- 261183; and

WHEREAS, it will be necessary for the City Manager to post or cause to be posted signs giving notice of the temporary closure of Pomerado Road not only within the limits of The City of San Diego but also inside the limits of the City of Poway; and

WHEREAS, the City of Poway has agreed to The City of San Diego posting signs along Pomerado Road within the limits of the City of Poway for the duration of the above-cited contract; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that, pursuant to California Vehicle Code Section 21101(e), Pomerado Road between Scripps Ranch Boulevard and Avenida Magnifica be closed to all traffic for the duration of the above-cited contract for improvements to Pomerado Road.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to close to all traffic except emergency vehicles as necessary, that portion of Pomerado Road between Avenida

Magnifica and the easterly City limits, to a point approximately 1500 feet east of Semillon Boulevard, for the duration of the above-cited contract for improvements to Pomerado Road.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to post or cause to be posted, appropriate signs for giving notice of the temporary road closure of Pomerado Road.
