WHEREAS, in approving the final map of Carmel Valley Neighborhood 5 Unit No. 3 subdivision, the City shall receive easement interests which will allow the quitclaim of existing general utility easements and the revestment of certain access rights within the area of the subdivision; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 261202-1, quitclaiming to BALDWIN BUILDING COMPANY, a California partnership, all of the City's right, title and interest in the general utility easements and access rights, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
