APPROVING MAP OF VILLAMAR UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Steven J. Hassett, a registered civil engineer, entitled "VILLAMAR UNIT NO. 1, being a subdivision of portions of Lots 1 and 2 in Block 1, portions of Lots 1 and 2 in Block 2, a portion of Lot 3 in Block 5, and Lot 2 and a portion of Lot 1 in Block 6 of Clairemont Garden, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 2947, filed in the office of the County Recorder of San Diego County, January 14, 1953 and a portion of Parcel B according to Parcel Map No. 768, filed in the office of the County Recorder of San Diego County, together with Cowley Way as dedicated to public use, and Cowley Way, Calle Neil and the unnamed alleys in Blocks 1 and 2, all as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Cowley Way, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on

behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs I, II and III of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of portions of Cowley Way, Calle Neil and an alley, approved by Council Resolution R-259599 on November 14, 1983, concurrently with the filing of the map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street is accepted on behalf of the public as heretofore stated, and that those easements listed in paragraphs I, II and III of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
