BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of that street easement deed of PRUDENT REAL ESTATE, INC., a California corporation, and THE PACIFIC COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of February 8, 1984, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 261210, granting to said City an easement for public street purposes in a portion of Lot 3, Block 5, and Lot 1, Block 6 of Clairemont Garden, Map No. 2947, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named COWLEY WAY.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
