WHEREAS, the Engineering and Development Director and the City Manager have recommended that such extension of time be granted said subdivider in which to complete the required improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:



BE IT FURTHER RESOLVED, that performance bond number 710631S, issued by Developers Insurance Company in the sum of \$235,846.00 is hereby accepted as surety for the required improvements in said subdivision, and substituted as Exhibit "C"

to the aforesaid agreement and that performance bonds numbered 202723 and 202724, in the total amount of \$235,846.00, issued by Cotton Belt Insurance Company, Inc., are hereby released.
