
WHEREAS, Section 102.0318 of the San Diego Municipal Code authorizes the City Engineer to issue Special Permits to do work prior to the filing of a final subdivision map, except when the subdivision is located within the Hillside Review (HR) Overlay Zone, in which case a Special Permit must be authorized by the City Council; and

WHEREAS, the subdivision known as PACIFIC CORPORATE CENTER is in the Hillside Review Overlay Zone and the subdivider thereof wishes to start grading prior to final map approval;

NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego hereby authorizes the issuance of a Special Permit for PACIFIC CORPORATE CENTER subdivision to commence grading prior to final map approval upon payment of all fees in connection therewith as well as provision of full surety to cover all improvements which will be included in the Subdivision Improvement Agreement.
