A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING THE CONSOLIDATION OF A GENERAL MUNICIPAL ELECTION AND A SPECIAL MUNICIPAL ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON NOVEMBER 6, 1984, WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, the Charter of The City of San Diego provides that commencing with the year 1984 the election to the office of Mayor shall be held every four (4) years, and that the General Municipal Election for this office shall be held on the same date in each election year as the California State General Election; and

WHEREAS, at a meeting held on July 23, 1984, the City Council of the City of San Diego adopted Ordinance No.

o- 16247 calling a Special Municipal Election to submit to the qualified voters of the City one proposition relating to ratifying an ordinance authorizing the acceptance from the Salk Institute for Biological Studies of a portion of Pueblo Lot 1324 and \$350,000 in exchange for a conveyance by the City to Salk Institute of 2.3 acres of dedicated Torrey Pines City Park Land and one proposition relating to an advisory measure on renaming San Diego Jack Murphy Stadium; and

WHEREAS, it is desirable that this General Municipal Election and Special Municipal Election be consolidated with the Statewide General Election to be held on the same date and that within the City of San Diego the election precincts, polling places, voting booths and election officials for the three

elections be the same, and that the Board of Supervisors of the County of San Diego be authorized to canvass the returns of the General Municipal Election and the Special Municipal Election and that these Elections and the Statewide General Election be held in all respects as if there were only one election; and

WHEREAS, in the year 1984, the Statewide General Election will be held on the 6th day of November; and

WHEREAS, this Council within the time required by law has or will adopt ordinances calling for a General Municipal Election and a Special Municipal Election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Board of Supervisors of the County of San Diego is hereby requested to consolidate the General Municipal Election for the office of Mayor and the Special Municipal Election to be held in the City of San Diego on November 6, 1984, with the Statewide General Election to be held on the same date.

- 2. The Board of Supervisors of the County of San Diego is requested to issue to all officers of the County charged with duties pertaining to the Statewide General Election appropriate instructions to take any and all steps necessary for the holding of a consolidated election.
- 3. The Board of Supervisors of the County of San Diego is hereby requested to authorize and direct the Registrar of Voters of the County of San Diego to perform the following:
 - (a) Furnish a tabulation of the number of registered voters in each Councilmanic district by precinct;
 - (b) Canvass the returns of the elections, including

absent voter ballots;

- (c) Furnish a tabulation of the number of votes given in each precinct; and
- (d) Furnish a tabulation of the number of votes given in each Councilmanic district by precinct.
- 4. That the City Clerk of the City of San Diego is hereby directed to file a certified copy of this resolution with the Board of Supervisors and Registrar of Voters of the County of San Diego.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized and directed to make payment to the Registrar of Voters in compliance with the Board of Supervisors' advance payment policy.
