Catherine M. Jagers	Police	\$ 225	Mrs. Jagers is an Intermediate Typist in the Traffic Divison. She suggested a coded filing system for material generated on the word processor. This is expected to save \$1,512 in the first year in time costs. This is a partial award pending a 12-month review.
Charles B. Anderson	Building Inspection	\$ 185	Mr. Anderson is a Building Inspector in the Building Inspection Department. He suggested the development of a color coded tagging system to identify plans. One year's experience has shown a savings of \$1,837 in time costs. This is the full award.
Kenneth A. Martinosky	General Services	\$ 60	Mr. Martinosky is a Service Writer in the Equipment Division. He suggested the throttle linkage be repaired instead of replaced on the Master Trucks with 6-71 engines. This resulted in a savings of \$198 in time and material costs. This is the full award.
