

RESOLUTION NUMBER R- 261241

Adopted on JUL 24 1984

WHEREAS, the annual administrative budget for the Southeast Economic Development Corporation ("SEDC") has been prepared in accordance with Section 2.02 of the Operating Agreement between SEDC and The City of San Diego; and

WHEREAS, the administrative budget is a part of the document on file in the office of the City Clerk as Document No. RR-261241 and presents a description of SEDC's work program for the coming year and the costs of existing and potential activities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the administrative budget contained in the document on file in the office of the City Clerk as Document No. RR- 261241 is hereby accepted and adopted.

2. That approval of this budget constitutes authority for the expenditure of available funds in Fiscal Year 1984/85 so long as funds are available from the tax increment generated by projects; from allocations of funds by the Council from such sources as community development block grants, sales tax or others; and from the allocations of funds by such entities as economic development administration and others.


3. That the City Auditor and Comptroller is hereby authorized to establish the necessary accounts and to appropriate and allot all monies available in each project fund

up to the amount budgeted herein and to record the expenditure of funds and the recovery of all accrued costs subject to the amount of revenues available in each project fund.

4. That SEDC's Executive Vice President, or his designee, is hereby authorized to make budgetary transfers between the budgeted line items in accordance with Section 1.07 of the Operating Agreement between The City of San Diego and SEDC which is on file in the office of the City Clerk as Document No. RR-
