RESOLUTION OF INTENTION FOR THE IMPROVEMENT OF LOGAN HEIGHTS BLOCK GRANT ALLEYS AND SEWER MAIN REPLACEMENT - CONTRACT NO. 3 UNDER THE PROVISIONS OF THE SAN DIEGO MUNICIPAL CODE AND THE IMPROVEMENT ACT OF 1911.

BE IT RESOLVED, that the Council of The City of San Diego proposes and intends to order the following work to be done and improvements to be made in said City under the provisions of the Improvement Act of 1911.

Add., Map No. 379; and BLOCK 336, Choates Add., Map No. 156.

That the said work hereinabove described in LOGAN HEIGHTS BLOCK GRANT ALLEYS AND SEWER MAIN REPLACEMENT - CONTRACT NO. 3 in said City, shall be done to the grade shown and indicated on the plans and profiles on file in the office of the City Clerk of said City, and said plans and profiles for the description of the grade at which the work is to be done.

If the Council of The City of San Diego decides at any time to abandon one or more of these projects, that decision shall not affect the validity of the remainder.

It is the opinion of the City Council that the public interest will not be served by allowing the property owners to take over the contract for the abovementioned improvements; therefore, Section 20421 of the Public Contract Code will not apply.
