BE IT RESOLVED, by the Council of The City of San Diego, that in connection with the issuance of not to exceed \$4,725,000 of Multifamily Residential Mortgage Revenue Bonds to help finance the construction and permanent financing of approximately 132 housing units to be located on Del Cardo Street, south of Palm Avenue, the Council hereby directs the Housing Commission staff to include a provision in the project documents to provide for an optional tot-lot, if such tot-lot is determined to be necessary at a future date.
