

That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$20,000.00 in the settlement of U.S. District Court No. 82-0305-S(M), Stephen Leonik v. City of San Diego, et al., and of each and every claim against The City of San Diego, its agents and employees, resulting from the bodily injuries of Stephen Leonik.

Be IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue a warrant check in the amount of \$20,000.00 made payable to "Stephen Leonik and his attorney, Pierre Pfeffer," in full settlement of the lawsuit and of all claims.
