

RESOLUTION NUMBER R- 261330

Adopted on AUG 6 1984

WHEREAS, during the City Manager's budget overview on May 15, 1984, brief mention was made of the financial impact to the City if the Jarvis IV initiative measure on the November 1984 ballot is approved by the voters; and

WHEREAS, the initiative measure (popularly referred to as Jarvis IV or the Spirit of Proposition 13) was written by Howard Jarvis, co-author of Proposition 13; and

WHEREAS, if approved by a majority of voters in November 1984, this initiative would amend article XIII A of the California State Constitution; and

WHEREAS, the Jarvis IV initiative would nullify the effects of recent court decisions and legislative actions which Mr. Jarvis feels have circumvented the intent of Proposition 13; and

WHEREAS, in addition, the initiative would impose restrictions on the ability of the state and local governments to raise revenues through the establishment of fees and assessments; and

WHEREAS, the total financial impact would be a one-time refund of \$19.7 million in FY 1986 and an ongoing revenue loss of \$4.7 million beginning in FY 1986, thus, in FY 1986, the total impact would be \$24.4 million; and

WHEREAS, these figures exclude any refunds or revenue loss from the zoo tax and assessment districts; and

WHEREAS, additionally, these estimates do not include any possible effects of Jarvis IV on the Water Utilities Department; and

WHEREAS, the City Manager, in Report No. 84-273, dated July 3, 1984, provided a comprehensive report and analysis to the Rules Committee setting forth all the provisions of and possible financial ramifications of the Jarvis IV initiative upon The City of San Diego in the event the ballot measure passes in November 1984; and

WHEREAS, in said Report No. 84-273, the City Manager recommended that The City of San Diego publicly express its opposition to the measure; and

WHEREAS, on July 9, 1984, the Rules Committee heard testimony on the matter, reviewed the information provided by the City Manager, deliberated thereon and voted unanimously (4-0) to accept the City Manager's recommendation to oppose the Jarvis IV initiative; and

WHEREAS, the Rules Committee now forwards the matter to the full Council with a recommendation that the Jarvis IV initiative be opposed by The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of said City, after review and discussion of the information contained in City Manager Report No. 84-273, dated July 3, 1984, and in consideration of the recommendations contained therein and also provided by the Rules Commission, does hereby express opposition by The City of San Diego to the Jarvis IV initiative which will appear on the November 1984 ballot.
