
ADOPTED ON AUG 13 1984

BE IT RESOLVED, by the Council of The City of San Diego (the "Council"), that the City Manager be, and he is hereby authorized to file a Housing Development Grant Application, a copy of which is on file in the office of the City Clerk as Document No.

RR- 261338, with the United States Department of Housing and Urban Development ("HUD"), under Section 17 of the United States Housing Act of 1937, which was enacted into law in Section 301 of the Housing and Urban-Rural Recovery Act of 1983, in the approximate grant amount of \$3.7 million for the purpose of assisting in the construction of 192 rental apartments, related commercial space and parking.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and directed to take such actions as are reasonably necessary in connection with meeting the terms and conditions contained in such application and to provide such additional information as may be required.
