CONSTRUCTION OF CHILDREN'S POOL FENCE.

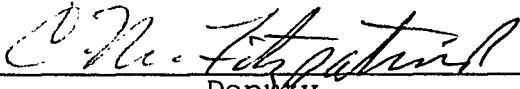

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$15,000.00 from Transient Occupancy Tax Fund 10224 and \$3,000.00 from CIP No. 20-001.0 ANNUAL ALLOCATION - MINOR IMPROVEMENTS to CIP No. 29-541 CHILDREN'S POOL FENCE.
