

RESOLUTION NUMBER R- **261349**

ADOPTED ON AUG 13 1984

WHEREAS, the Intergovernmental Relations Department, at the request of the Mayor, analyzed three State legislative proposals relating to programs and funding for senior citizens; and

WHEREAS, the measures involved are: (1) SB 1337 (Mello) (as amended June 21, 1984) regarding Adult Day Health Care; (2) SB 1359 (Garamendi, et al.) (as amended June 25, 1984) regarding Senior Center Bond Act of 1984; (3) SB 1996 (Mello, et al.) (as amended July 2, 1984) regarding Senior Nutrition Maintenance and Home Delivered Meals Act of 1984; and

WHEREAS, the Intergovernmental Relations Department, in IRD Reports No. 84-46, 84-44, and 84-45 respectively, analyzed the above-cited bills and reported thereon to the Rules Committee with appropriate recommendations; and

WHEREAS, the Rules Committee on July 23, 1984 reviewed the reports of IRD and approved the recommendations therein on a 4-0 vote and now forwards said matters to the full Council with a recommendation for City Council support; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that upon recommendation and approval of the Rules Committee and review of IRD Reports No. 84-46, 84-44 and 84-45, this Council hereby expresses its support of SB 1359 (Garamendi, et al.) and SB 1996 (Mello) and support for SB 1337 (Mello) if amended, as recommended in IRD Report No. 84-46.
