BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer \$125,000 from Fund 18520, Dept. 5821, Org. 2101 (Contingencies) to Fund 18520, Dept. 5814, Org. 1412 (Food Bank at \$75,000) and Fund 18520, Dept. 5814, Org. 1413 (Refugee Assistance Program at \$50,000) and to expend said funds for the above program.
