## RESOLUTION NUMBER R- 261362

ADOPTED ON AUG 13 1984

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO ELECTING TO PAY OUT OF MUNICIPAL FUNDS ONE HUNDRED PERCENT (100%) OF AN AMOUNT IN LIEU OF TAXES WHICH WOULD OTHERWISE BE LEVIED UPON PROPERTY WITHIN THE CITY BY THE SAN DIEGO COUNTY WATER AUTHORITY FOR THE FISCAL YEAR BEGINNING JULY 1, 1984, AND ENDING JUNE 30, 1985.

WHEREAS, The Board of Directors of the San Diego County
Water Authority ("Authority") will levy a tax upon taxable
property within the Authority's jurisdiction for the fiscal year
beginning July 1, 1984 and ending June 30, 1985 for the
following purposes:

- 1. Meeting the interest and sinking fund requirements on all outstanding bonded indebtedness of the Authority, including the payment of principal and interest on any outstanding refunding bonds, as well as any unissued bonds, which may have been authorized by the electors of the Authority and which in the judgment of the Board of Directors will be issued prior to the time that money to service such bonds would be available from the next subsequent tax levy;
- 2. Meeting the obligations of the Authority to the United States of America and any board, department or agency thereof;

- 3. Meeting special taxes levied upon property in the City pursuant to Section 9 of the County Water Authority Act as prescribed by the terms of the applicable resolution of the Board of Directors fixing conditions for annexation of such area to the Authority;
  - 4. All other Authority purposes; and

WHEREAS, this Council did on the 3rd day of August 1983 adopt Resolution No. R-259006 by which the Council declared its intention to pay out of municipal funds one hundred percent (100%) of an amount in lieu of taxes which would otherwise be levied by the Authority upon property within the City for the fiscal year commencing July 1, 1984 and ending June 30, 1985; and

WHEREAS, there is now available or will be available on the date required, in the appropriate fund of The City of San Diego, a sum sufficient to pay one hundred percent (100%) of the in lieu amount; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The Council hereby elects to pay out of the appropriate fund of the City, the sum not to exceed \$4,000,000.00 and hereby appropriates such sum as payment of one hundred percent (100%) of an amount in lieu of taxes which would otherwise be levied upon property within the City by the San Diego County Water Authority for the fiscal year commencing July 1, 1984 and ending June 30, 1985.

Section 2. Payment of the in lieu amount shall be made on the dates and in the amounts indicated in Section 3 of this resolution for the following purposes:

- a. The sum not to exceed \$4,000,000.00 representing one hundred percent (100%) of the in lieu amount to be paid for the purpose of meeting the interest and sinking fund requirements on outstanding bonded indebtedness, including payment of the principal and interest on any outstanding refunding bonds, as well as any unissued bonds, which may have been authorized by the electors of the Authority and which in the judgment of the Board of Directors will be issued prior to the time that money to service such bonds would be available from the next subsequent tax levy.
- b. The sum not to exceed \$4,000,000.00 representing one hundred percent (100%) of the in lieu amount to be paid for the purpose of meeting the obligations of the Authority to the United States of America and any board, department or agency thereof, and for all other Authority purposes.

Section 3. The following is the schedule of payments to be made:

August 27, 1984 not to exceed	\$1,000,000.00
November 10, 1984 not to exceed	\$1,000,000.00
February 10, 1985 not to exceed	\$1,000,000.00
May 10, 1985 not to exceed	\$1,000,000.00

Section 4. The City Clerk is hereby directed to file immediately with the Comptroller of the Authority a certified copy of this resolution with financial statements of the Water

Utilities Department and of the City as required by law to be furnished by the City to the Authority.
