

RESOLUTION NUMBER R- 261371

ADOPTED ON AUG 13 1984

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and directed to proceed with the issuance of a Request for Proposals, with a 45-day response period, for the development of the City-owned property at Home Avenue and Federal Boulevard in accordance with the currently proposed community plan.

BE IT FURTHER RESOLVED, that the proposals received shall be scheduled for review by the Public Facilities and Recreation Committee on October 3, 1984, and for review by the City Council at the next Council meeting immediately following the Committee meeting.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to take steps necessary to ensure that the Mid-City community representatives have input with regard to the development of plans for proposed improvements on the City property.

BE IT FURTHER RESOLVED, that City staff is directed to expedite the Barrio Logan Urban Industrial Plan and to include a potential transportation center in the Plan.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to negotiate with American Journey Corporation for potential development within the Barrio Logan Urban Industrial Plan area.

BE IT FURTHER RESOLVED, that City staff is directed not to relocate the pistol range facility to any community without that community's input and without the approval of that community's citizen representatives.
